

DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible)

The purpose of this modification is to: (1) transfer funds from the basic contract to Task Order 6, and (2) modify the period of performance end date due to an administrative oversight (from 4/30/2006 to 7/20/2006).
