Dear Mr. Cihiy:

We have received your Letter of Credit dated August 9, 2006 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 37-02226-02 in the increased amount. In order to continue our review, we need the following additional information:

1. Since the amount of financial assurance has changed, it requires a change to the Standby Trust Agreement. Schedule A and B of the standby trust agreement needs modified to the reflect the new value.
2. The change in financial assurance also requires a new Certification of Financial Assurance be written. Current guidance for creating this document is contained in NUREG-1757, Volume 3, "Consolidated NMSS Decommissioning Guidance, Financial Assurance, Recordkeeping, and Timeliness." Please see section A.2 on page A-17 for specific guidance. Please follow closely the model provided on page A-23.
