All parties indicate that they have no objection to the proposed extension of time.

DISCUSSION

On Friday, August 18<sup>th</sup>, 2006 the Staff obtained five boxes of additional documents from FirstEnergy Nuclear Operating Company. A cursory review of those documents by NRC Staff indicates that some of the documents may provide support for or opposition to the Orders which are the subject of the above captioned proceedings. In accordance with § 2.336(d) the Staff intends to disclose these documents to all parties. The documents are currently in the NRC Region III Office. The documents will be shipped to NRC Headquarters today. The Staff needs an additional two weeks in order to copy and index the documents and provide them to all parties. The Staff will produce the documents as soon as possible, but no later than

September 15, 2006.

Therefore, the Staff respectfully moves for an extension of time to complete its § 2.336(d) disclosures.






