| Summary: Mr. Lightfoot is the RSO of the above licensee. On August 28, 2006, he was notified that a waste truck containing Grand View waste was rejected by a waste site because it set off a radiation alarm. A measurement revealed that the waste contained a diaper of solid excrement which was contaminated with 36 microcuries of I-131. A patient who had been treated for hyperthyroidism a couple of weeks ago returned shortly before this incident and was admitted to the hospital. The waste has been linked to this patient. Mr. Lightfoot will call back in the near future with more details and confirmation of the above.
