3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on January 17, 2000. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of OOCL Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about January 25, 2000. The containers will then be loaded onto the rail for importation to Detroit, MI. The containers will enter the USA at Detroit, MI on or about January 29, 2000, and will continue on rail to Chicago, IL. The inland transportation from Chicago, IL to Metropolis, IL will be the responsibility of RSB logistic Services Inc.
