Fitness for Duty Program Six Month Performance Report January-June 2006

PROGRAM SUMMARY:

The Arkansas Nuclear One annual random testing rate is 50 percent. During this six month reporting period, approximately 30.0 percent of the population was randomly tested. The rate of positive tests from random testing for this period was 0.45 percent.

POSITIVE RESULTS:

During this six month reporting period, 679 samples were collected and tested. One sample was confirmed positive for an illegal drug. Two contractors refused to test.

MANAGEMENT ACTIONS:

One contractor submitted a random sample that tested positive for cocaine at the NRC cutoff level. A second contractor refused to submit a random sample. Both contractors' unescorted access was revoked.

A third contractor refused to submit a post-accident for-cause sample and his unescorted access was revoked.

EVENTS REPORTED TO THE NRC:

None.

PROGRAM EVALUATION:

No programmatic problems were identified during this reporting period.
