SUBJECT: SURETY REVIEW FOR EXXONMOBIL'S HIGHLAND RECLAMATION
PROJECT (TAC LU0141)

Dear Mr. Burnham:

I am responding to your letter dated August 16, 2006, concerning the surety for the ExxonMobil Refining and Supply Company's (ExxonMobil) Highland Reclamation Project. You requested that the current surety of \$1,250,000 be maintained because reclamation activities are nearing completion and fewer unanticipated activities are expected. ExxonMobil's surety estimate specifically addresses: groundwater restoration/well plugging; tailings impoundment area reclamation; project management; and long-term surveillance. A contingency of 15 percent has also been added as a line item. The original \$250,000 long-term surveillance and control fee has been adjusted to \$769,000 due to inflation. Based on our review of the revised cost estimate, we have concluded that ExxonMobil has appropriately estimated the cost of completing the remaining work and has adequately addressed the effects of inflation on the long-term surveillance fee. Therefore, we agree that the current surety amount of \$1,250,000 in License Condition 23 of Source Material License SUA-1139 for ExxonMobil's Highland uranium mill is acceptable.

An environmental review was not performed because this action is categorically excluded under 10 CFR 51.22 (c)(10)(i).
