No mention is made of the impacts of the project on property values in the Lake Anna Area.

Information about how much of the cost will be borne by Dominion and how much

by taxpayers is absent.

The EIS basically says that all the road problems will be fixed to support transport of the huge number of construction personnel. This is contrary to the current reality in Virginia which is that there is limited or no money for roads and the needs are great throughout the region.

The list of alternatives did not include life extension of the existing two plants, retirement of those plants, detailed analysis of the use dry coolers on Unit #3, or the retrofit of a cooling tower on Units #1 and 2 .

The DEIS does not inform the public that private insurance will not provide total coverage for this kind of facility and that, in fact, taxpayer funds are used to self insure.

Furthermore, by creating a twenty year window for the action, the ESP process makes conclusions about the Site and its environment, that are likely not to be true soon after the ESP is approved, such as regional population.

Please go back to the analysis process, do a thorough review, and issue a complete Draft EIS. Only then would we have a legitimate process to receive public input on this proposal. Thank you.
