This is in reference to my letter and Notice of Violation, dated May 31, 2006, that was sent to you following a safety inspection conducted by Mr. Todd Jackson of my staff at your Hamilton Township location on February 9, 2006. A copy of my letter and the Notice of Violation is enclosed. As stated in my letter, you are required to respond to the Notice of Violation. Mr. Jackson has attempted to contact you by telephone and email on numerous occasions to determine the status of your response to the Notice of Violation. Mr. Jackson has also left messages with your receptionist. As of the date of this letter, NRC has not received a response. If a reply to the Notice of Violation is not received within 10 days of the date of this letter, an Order or a Demand for Information may be issued as to why the license should not be modified, suspended, or revoked, or why such other action as may be proper should not be taken.
