The discussion centered on the fact that the licensee's amendment request did not describe the actual sampling that took place to support the FSS for the excavated pit located in the southern end of Section 2. I presented the option of voiding the current amendment request and having Whittaker submit a new amendment request with the actual FSS sampling scheme. Kevin Taylor stated that Whittaker was about to submit the Decommissioning Plan (DP) (within several weeks) and asked if he could include the sampling information, along with the other information in the amendment request, in the DP instead.
