Dear Mr. Wroblewski:

Enclosed is Amendment No. 105 to your NRC Material License No. 13-00133-02 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In correspondence dated June 2, 2006, and August 3, 2006, you indicated that you wished to release the Radiation Oncology Hot Lab at 2015 Jackson Street, Anderson, Indiana; the cardiac catheterization lab at 2001 West 86th Street, Indianapolis, Indiana; and an imaging room at 1300 South Jackson Street, Frankfort, Indiana for unrestricted use. The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from these areas of use and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for these areas of use and they are suitable for unrestricted use.

Also, for future reference, it would be helpful to include a complete historical review of all actual licensed materials used in areas and/or locations of use, including sealed and unsealed sources, spill, and contamination. The historical review should specify when and where the materials were used and how, when and by whom the materials were disposed of (shipped off site, decayed -in-storage, sanitary sewer disposal, etc.) or transferred (may be a future date). Please also refer to section 15.5.3 in NUREG 1757, Vol. 1, Rev. 1, available on our website, for additional assistance.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). The NRC's document system is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>. The enclosed license document is exempt from public disclosure in accordance with 10 CFR 2.390, because its disclosure to unauthorized individuals could present a security vulnerability.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
