Control No. 315511 – Re - Amendment request by NRC Form 314 dated June 15, 2006, regarding request to terminate their NRC license, License No. 21-14922-01.

SUMMARY

In a telephone conversation with Mr. Kling on this date, I related that we will need the following additional information before proceeding with their request:

1. Please confirm that both the TN (Texas Nuclear) Model 5190 gauge with a nominal 10 millicurie Cs-137 sealed source and the ABB Model 0-7 gauge with a nominal 250 millicurie Kr-85 sealed source, as shown on both the leak test and transfer/disposal records, submitted with NRC Form 314, were both possessed under the General License provisions of 10 CFR Part 31.5 and not under your Specific License No. 21-14922-01. (Please note regarding your reference to the licensee's one General Licensed gauge (with a KR-85 sealed source) which remains in its current location and will be used by the new owner, Otsego Paper, Inc., that this transfer is subject to the criteria in 10 CFR 31.5 regarding the transfer of a device from one General Licensee to another General Licensee).
2. Please confirm that no leaking sealed sources were ever possessed by the licensee, based on routine leak test data.
3. Please provide a copy of the license issued by the State of Louisiana to QSA Global, Inc. of Baton Rouge which shows that they were authorized to receive/possess the make and model of gauges you transferred to them for disposal.

Licensee was requested to provide response, in writing, to me (as additional information to Control Number 315511) by facsimile at 630-829-9782. No follow-up hard copy is needed. Any questions may be directed to me at 630-829-9829.


