The NRC NMSS Office Director has just signed an Order modifying EnergySolutions, LLC's (formerly Envirocare of Utah, LLC's) exemption from 10 CFR Part 70. The conditions in this modified Order reflect the change in name from Envirocare to EnergySolutions; no other substantive changes were made to the conditions. This action was taken in response to a March 3, 2006 request from EnergySolutions.

The signed Order will now be sent to our Office of Administration for publication in the Federal Register.
