The purpose of this modification is as follows:

- (1) To increase the Firm Fixed Price of the order. Line Item 0001 of the order is hereby increased by \$17,102.89 from \$109,326.33 to \$126,429.22 for the completion of self-assessments for an additional five (5) systems. Line Item 2 - Travel of the original order will continue to be reimbursed at actual cost in accordance with the order's terms and conditions. The total for this order is increased from \$116,826.33 to \$133,929.22.
- (2) To extend the period of performance.

Accordingly, the following sections of the order are hereby modified:

1. SOW Section 1.0, OBJECTIVE, Paragraph 2, is revised to increase the number of security self assessment security questionnaires from 34 to 39.

SOW Section 8.0, SPECIFIC TASKS, last paragraph, is revised to increase the number of final Major Application and General Support Systems AISSS reports to be completed, approved and accepted from 34 to 39.

2. SOW Section 4.0, PERIOD OF PERFORMANCE, is deleted in its entirety and replaced with the following:

"The period of performance is June 26, 2006 through August 7, 2006."

All other terms and conditions remain unchanged.
