MEETING SUMMARY

SUBJECT: SUMMARY OF APRIL 20, 2006 ANNUAL ASSESSMENT MEETING WITH
ENTERGY NUCLEAR OPERATIONS, INC.

On April 20, 2006 at 2:00 p.m., an Annual Assessment Meeting was conducted at the Quality Inn, Brattleboro, Vermont, between the Nuclear Regulatory Commission (NRC) and Entergy Nuclear Operations, Inc. (Entergy). The NRC requested the meeting with Entergy management to discuss the NRC's assessment of the safety performance of Vermont Yankee Nuclear Power Station for the calendar year 2005.

The NRC presented and discussed its assessment of the safety performance of Vermont Yankee for the period between January 1 through December 31, 2005. The NRC presentation included background on the Reactor Oversight Program (ROP), an summary of national performance assessment results, an overview of Vermont Yankee's performance during calendar year 2005, and a discussion of general NRC issues. As part of this regulatory performance meeting, Entergy presented its perspective regarding the plant's performance and operation goals for 2006.
