Director Miller's letter contains a number of errors; for example:

- > Your stated basis that licensees have been grossly negligent in
- > failing to measure uranyl oxide gas combustion products of DU
- > munitions, and in failing to establish the correct toxicological
- > profile of uranium combustion product exposures, presumes an
- > NRC requirement to do so. However, there is no NRC
- > requirement to measure uranyl oxide gas combustion products.

On the contrary, the Atomic Energy Act requires the Comission to protect the health and safety of the public and the environment, which requires such knowledge as establishing the correct toxicological profile for regulated substances.

Director Miller also confuses the terms "modest" and "moderate," among other errors, regreably.
