Forty (40) TNF-XI shipping containers of which forty (40) contain enriched UO_2 and none (0) are empty. The shipment contains 8,522 kgU and 409 Kg ^{235}U at an average enrichment of approximately 4.80 wt% U^{235} . The TNF-XI's are loaded in three sea containers.

4. Schedule


