Model 6B-1A - this model number doesn't exist, it is probably an SR-1A

S/N M-2802 - it is a certificate that we maintain

The certificate said it was a 120 mCi source from 1988

The equipment might be categorized as a DENSART 3440

Ron wasn't sure if he was looking for 1 or 2 sources on the order. Could you perform your sleuthing function and see what you can find out? He will be out of the office until the week of October 2nd.
