Dominion Resources Services, Inc. (Dominion) requested a meeting with staff for the purpose of discussing organizational changes at Dominion, spent fuel loading schedule and needs and the effects of 10 Code of Federal Regulations (CFR) 50.68 rulemaking. Mr. Tom Brookmire, Dominion, made a presentation to staff.

The presentation (Attachment 2) included information about the ISFSI status at Surry, North Anna, Millstone, and Kewanee. All planned cask loadings for Surry's site specific license are complete. The license renewal inspection for Surry was completed in July 2006. Surry will begin transitioning to a general license for the NUHOMS HD at a third ISFSI pad. The first loading for the general license is planned for summer 2007. The North Anna ISFSI will hold a welding dry run for the NUHOMS HD in the near future, with the date still to-be-determined. Loading is tentatively planned for July 2007. Millstone plans to load NUHOMS 32PT canisters in late 2007. Dominion is currently designing an ISFSI for Kewaunee and plans to load NUMOMS 32PT in August 2008.

Staff discussed the current status of the NUHOMS HD rulemaking and informed Dominion that the tentatively scheduled date for the rulemaking is January 2007. Additionally, Dominion representatives discussed the rulemaking schedule for 10 CFR 50.68 and options for Dominion to amend its 10 CFR Part 50 license or await rulemaking.
