**Subject:** Proposed Protective Order (Oyster Creek Nuclear Generating Station License Renewal)

Dear Ms. Wolf:

In response to your email yesterday, counsel for AmerGen discussed our proposed Protective Order and Nondisclosure Affidavit (as served on the Board and the parties on April 15, 2006) with counsel for Citizens on April 25. During that conversation, counsel for AmerGen and Citizens agreed on certain modifications to those two documents. However, counsel for Citizens had additional comments and stated then that he would provide AmerGen with a proposed, revised version of the two documents incorporating Citizens' additional comments for AmerGen's review. We had not heard from Citizens on this matter until late last week, at which time we were asked to transmit to counsel for Citizens a "Word" version of the drafts. Yesterday, I transmitted a revised Word version to Citizens' counsel. We have corresponded and will attempt to resolve any further disagreements by this Friday, May 19. If we are unable to reach agreement by that time, then AmerGen will promptly provide its proposed Protective Order and Nondisclosure Affidavit to the Board.
