Dear Dr. Klein:

The purpose of this letter is to comply with the provisions of Section 651 (e) of the Energy Policy Act of 2005, regarding the licensing of certain naturally occurring and accelerator produced radioactive materials now defined as byproduct materials in Section 11e.(3) and 11e.(4) of the Atomic Energy Act of 1954 as amended.

On May 21, 1963, Arkansas entered into an Agreement with the Commission under Section 274b. of the Atomic Energy Act of 1954, as amended. Under that Agreement, the State of Arkansas licenses byproduct material as defined in Section 11e.(1) of the Atomic Energy Act. In addition, Arkansas has historically and currently licenses the naturally occurring and accelerator produced radioactive materials now defined as byproduct material in the Energy Policy Act of 2005.

The Radioactive Materials Program for licensing the new byproduct material is not separate and distinct from the program for licensing 11e.(1) byproduct material, and no changes have been made to the licensing program that would impact the previous Integrated Material Performance Evaluation Plan (IMPEP) finding of adequacy. Further, we intend to continue to license the new byproduct material under the same program.

Accordingly, I certify to the Commission that our state has a program for licensing byproduct material, as defined in paragraph (3) or (4) of Section 11e. of the Atomic Energy Act of 1954, as amended. I also certify this program is adequate to protect public health and safety and we intend to continue our regulatory responsibility with respect to the byproduct material.

This certification is effective on the date of publication of the U.S. Nuclear Regulatory Commission's (NRC) *"Plan for the Transition of Regulatory Authority Resulting from the Expanded Definition of Byproduct Material."*
