RE: Submittal of notification that operations with radioactive materials under USNRC License Number 24-15595-01 have been discontinued in Building L and sections of Building B.

Dear Mr. Null:

Due to business decisions Aptuit, Inc. has discontinued operations with radioactive materials under USNRC License Number 24-15595-01 in Building L and in sections of Building B located at the Aptuit, Inc. facility at 10245 Hickman Mills Drive, Kansas City, Missouri. This letter serves as notification pursuant to 10 CFR 30.36(d) that operations utilizing radioactive materials were ceased in these areas on October 1, 2006.

The aforementioned areas meet the criteria for Decommissioning Group 2 as described in the Consolidated NMSS Decommissioning Guidance, NUREG-1757, Volume 1, Revision 1. As the procedures required for decommissioning these areas are not expected to increase potential health and safety impacts to workers or to the public, and a decommissioning plan is not required by license condition, Aptuit, Inc. plans to proceed with a final status survey (FSS) of the impacted areas. A Historical Site Assessment (HAS) has been completed and the final status survey plan (FSSP) is being prepared. The FSS will follow the methodology described in the Multi-Agency Radiation Survey and Site Investigation Manual, NUREG-1575, Revision 1. The Final Status Survey Report will be submitted to the NRC upon completion.

**SUBJECT: TITLE 10 CODE OF FEDERAL REGULATIONS PART 30, SECTION 30.36 (d),
"TIME RULE NOTIFICATION"**

Dear Ms. Barton:

This refers to your August 10, 2006, letter informing the NRC that you intend to cease activities in certain buildings in which licensed materials have been used. Your letter indicates that you have reviewed the provisions of 10 CFR 30.36(d) and (g), and have made a determination that residual levels of radiological contamination can be addressed under the current provisions of your license, and as such does not require the submission of a decommissioning plan. We appreciate your notification and look forward to the receipt of the final status survey as required by 10 CFR Part 30.36(j).

Additionally, we request that you notify this office when activities actually cease, and when any survey and remediation activities are initiated. We may consider having an NRC decommissioning inspector visit your facility to observe the performance of these activities in process.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS). 


