Dear Mr. Perkins:

This letter confirms the telephone conversation between Bob Link of your staff and Manuel Crespo of this office on March 16, 2007, concerning a pre-decisional enforcement conference. This meeting is being conducted at your request, and is scheduled for April 12, 2007, at 8:00 a.m. (EDT). The purpose of the meeting is to discuss the apparent violations associated with the Hydrogen Fluoride (HF) leak on October 23, 2006. The apparent violations were discussed in NRC Inspection Report 70-1257/2006-010. The location of the conference will be at the NRC Region II Office, Sam Nunn Atlanta Federal Center, 61 Forsyth Street, S.W., Suite 23T85, Atlanta, Georgia. This will be a Category 1 meeting in which the public is invited to observe and will have the opportunity to communicate with the NRC staff after the business portion, but before the meeting is adjourned, as per the NRC policy statement "Enhancing Public Participation in NRC Meetings," published in the Federal Register: May 28, 2002 (Volume 67, Number 102, Page 36920-36924). A Meeting Notice is enclosed.
