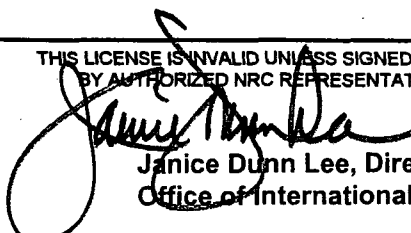
The shipment of Australian, Canadian and possibly Chinese-obligated material is authorized.
