As per NRC licensing guidelines, TranSystems Corporation is requesting the following amendments to Materials License number 24-32091-01:

License Condition 10. Radioactive material may be used or stored at the licensee's facilities located at 1136 W Cambridge Circle Drive, Kansas City, KS; 115 South 6th Street, Suite B, Independence, KS and temporary jobsites of the licensee anywhere in the United States where the U.S. Nuclear Regulatory Commission maintains jurisdiction for regulating the use of licensed material.

We have moved our storage location from Lenexa, KS to the Kansas City, KS address listed above. In addition, we have deleted our Lenexa, KS office location. Leak tests were performed on all gauges moved from Lenexa to verify source integrity. Copies of those leak tests are attached. In addition, radiation readings were performed at the old storage locations and only background readings existed. Prior to moving in at Cambridge Circle tests were taken and survey results were negligible. A diagram of the Kansas City, KS office is attached. All postings have been removed from Lenexa and relocated to the Cambridge Circle office.

License Condition 11. The radiation safety officers for this license shall be John Cooper, Scott Sharp and Clint Hamblin.

The RSO's indicated on the license have changed to the individuals listed above. Scott Sharp completed RSO training administered by Troxler Electronic Laboratories Inc. on November 3, 2005. Clint Hamblin completed RSO training administered by Troxler Electronic Laboratories Inc. on June 8, 2006. A copy of their training certificates is attached.

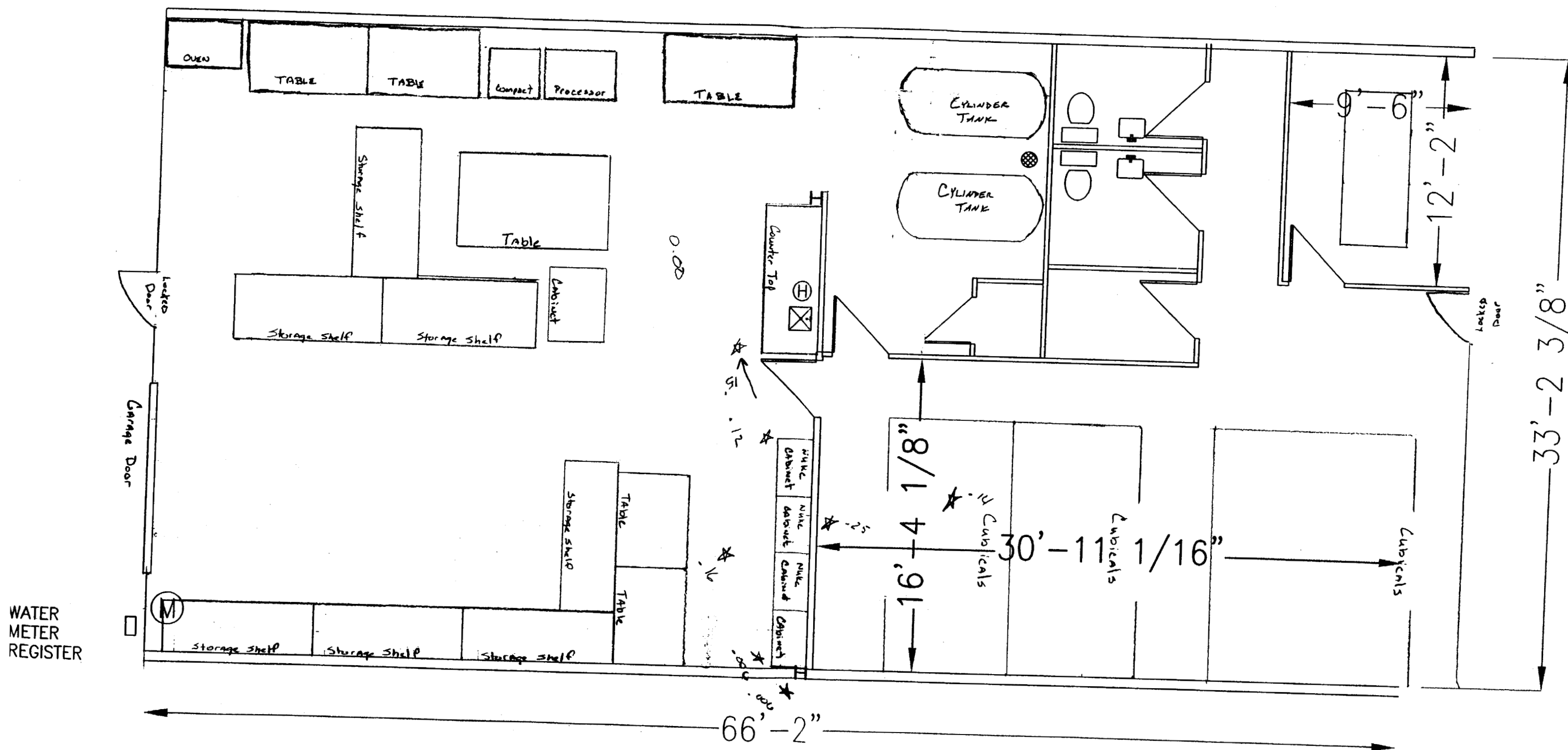
