SUBJECT: DELEGATIONS OF AUTHORITY

Pursuant to the reorganization approved by the Commission to become effective January 5, 1997, the Executive Director for Operations (EDO) no longer serves as the agency Chief Financial Officer (CFO). The CFO is hereby delegated the authority to take such action as is necessary to carry out all the functions specified in the Chief Financial Officers Act of 1990, subject to the limitations prescribed herein. This includes the authority to take the following actions:

- a. Supervise, direct, coordinate and approve the activities, of the various organizational units within the Office of the Chief Financial Officer.
- b. Grant waivers for recovery of less than full cost under reimbursable agreements. (This authority may be further redelegated.)
- c. Exercise all authority vested in the Commission under 10 CFR Parts 170 and 171, including the decision to grant or deny requests for exemption from the annual fees as imposed pursuant to the Omnibus Budget Reconciliation Act of 1990, as amended, and as implemented through 10 CFR Part 171. (The authority to grant or deny requests for exemption from annual fees is delegated solely to the CFO and may not be further redelegated. All other elements of this authority may be further redelegated.)
- d. Execute interagency actions for the acquisition of goods and services necessary to carry out the functions of the Chief Financial Officer, except for actions required by law or regulation to be approved by the Chairman or the Commission. (This authority may be further redelegated only to the Deputy CFO.)
- e. Appoint authorized NRC certifying officers in accordance with applicable legal requirements. (This authority may be further redelegated.)



- f. Exercise authority to sign fiscal and other financial and accounting documents on behalf of the NRC. (This authority may be further redelegated.)

This delegation supersedes any previously issued delegations.
