**STRATEGIC TEAMING AND RESOURCE SHARING (STARS)  
COMMENTS ON PETITION FOR RULEMAKING (PRM-73-13)  
(72 FR 17440)**

Dear Ms. Cook,

The Strategic Teaming and Resource Sharing (STARS)<sup>1</sup> nuclear power plants would like to take advantage of this opportunity to comment on the subject proposed rulemaking. STARS worked closely with the Nuclear Energy Institute (NEI) Security Rulemaking Task Force to review and comment on the proposed rule. Based on our review, STARS strongly endorses the comments submitted by NEI on behalf of the nuclear industry via NEI's letter dated June 22, 2007.

STARS believes rulemaking to prevent an individual from gaining access to the protected area of a nuclear plant, whether escorted or not, when information becomes known to the licensee that would prevent the individual from gaining unescorted access to the protected area is appropriate.

However, requiring the use of armed security officers as escorts for visitors is completely unwarranted. In the last several years with the increased emphasis on security, only people with a work-related need for entry are typically allowed access as visitors. The petitioner has not cited a single instance demonstrating the inadequacy of the current process. For these reasons, STARS believes this request should be denied.
