Dear Sir or Madam:

This letter is to notify you that Richard Grazzini has retired from MPI Research. His duties with respect to the above license will be assumed by Kevin Lloyd, General Manager Analytical Sciences. There are no other changes in the personnel named on the license.

This letter is also to notify you that MPI Research has decided to cease all activities under license 37-30095-01. The present inventory of radioactive material under the license is 0.5 millicuries ^3H and approximately 39 millicuries of ^{14}C . With the exception of several samples that might be returned to clients, all radioactive material will be packaged for disposal as radioactive waste. The radioisotope laboratory is only one room, room 101 in Building 1.

Work is now underway to survey all the equipment in room 1-101 for contamination prior to removal from the room. After all the equipment is removed and the radioactive waste has been packaged a final survey will be conducted of the empty radioisotope laboratory. The room will then be released for remodeling into office space. The room 1-101 has been surveyed for contamination on a weekly basis and essentially no detectable contamination has been found. We do not expect any significant decontamination of the room or any of the equipment to be required. We will provide the NRC copies of the final survey when it is complete. We will also provide a completed NRC Form 314 when the radioactive waste has been transferred to a broker for disposal.

Please advise MPI Research if the NRC wishes to conduct any confirmatory surveys when the room has been emptied and prior to the start of remodeling. We anticipate that all items, except for radiation monitoring equipment and packaged waste, will be removed from the laboratory by 3 Aug 07. The laboratory would then be available for confirmatory surveys the week of 6 Aug 07.
