Summary: In the letter dated June 22, 2007 the licensee requested the addition of Christopher Ladd, M.D. as an AU of I-131 < 33 millicuries. An ADAMS search revealed that Dr. Ladd was authorized for this on the Chambersburg license. However, he was removed from the license in 5/2000, 2 months outside the seven year window. After discussing this with Omar, he indicated that Dr. Ladd had done a case with Dr. Benke in 2006, which was documented on a preceptor form. Omar will fax in that information for review to determine if it meets the requirement of recentness.
