The staff and licensees achieved final closure on one FAQ. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs. The staff and licensees also discussed the NRC Enforcement Discretion Policy relating to the NFPA 805 transition, and the handling of fire induced risk during low power and shutdown plant conditions.
