
This letter is to serve as a request for an amendment to our license regarding the items below:

1. We wish to remove G. Michael Brown as the RSO and add Jason Barnett as the RSO. He has successfully completed the NDC Systems training program – certificate is attached.
2. The activity for each americium-241 sealed source is as follows:
 - a. Gauge 1282 contain 80.00 mCi
 - b. Gauge 2195 contains 25.00 mCi
 - c. Gauge 2569 contains 80.00 mCi
3. All gauges are stored within a locked unit that only our custodian has access to. No member of family or public has access to this locked unit. All gauges are stored so that the radiation dose to the public is within the regulatory limits.
4.
 - a. Gauge 1282 in possession of Michael Hunt has not been moved from its location of 340 Garfield Street, Kingsford, MI
 - b. Gauge 2195 was in the possession of Bob Bilodeau at 138 Asher Lane, Spring Mills, PA 16875. Bob has left the company so the gauge responsibilities are being transitioned to Mike Brown at 564 Shanely Lane, Port Matilda, PA 16870.
 - c. Gauge 2569 in possession of Bill Robertson moved from 219 North Pinetta Drive, Richmond, VA to 3701 Liberty Point Drive, Midlothian, VA to 4475 Pouncey Tract Rd, Unit 1001, Glenn Allen, VA 23059. He is now in the process of moving to 8703 Walton Farms Ct, Richmond, VA 23294. Drawing of storage location is attached.

- d. Leak test for all gauges were sent with previous request.
- 5. We do not have any history of any leaking sealed source.
- 6. All radionuclide's have been removed from their prior storage locations and transferred to their new storage locations.
