We are kindly requesting any documents or procedures needed for us to be filled out in order for this change to take place


Herewith attached are the documents showing the transfer of the Troxler Gauge, everything will remain the same as far as usage and facilities.

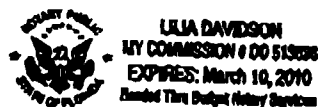
