Accordingly, the following sections of the order are hereby modified / inserted:

1. Section 23. 52-232-7 Payments Under Time-and-Materials and Labor-Hour Contracts (FEB 2002) Alternate I (MAR 2000): Paragraph (2) is hereby revised to include the following:

"Unless otherwise prescribed in the Schedule, the Contracting Officer **shall not** withhold **5** percent of the amounts due this paragraph (a), but the total amount withheld shall not exceed \$50,000. This amounts withheld shall be retained until the execution and delivery of a release by Contractor as provided in paragraph (f) below."

All other terms and conditions remain unchanged.
