SUBJECT: REQUEST TO REVISE BWX TECHNOLOGIES, INC.'S, PHYSICAL  
PROTECTION PLAN (TAC L31972)

Dear Ms. Morrell:

We have completed our review of the changes to the BWX Technologies, Inc.'s Physical Protection Plan (Plan), submitted by your letter dated March 15, 2007. We have confirmed that they meet the requirements of 10 CFR 70.32(e) and none of the changes decrease the effectiveness of the Plan. The U.S. Nuclear Regulatory Commission (NRC) will incorporate a revised safeguards license condition SG-6.1 to your license when the license amendment for the new container storage facility is issued.

Safeguards Condition SG-6.1 will read as follows:

The licensee shall follow the measures described in the Plan titled, "BWX Technologies Nuclear Products Division, Physical Protection Plan," dated March 15, 2007, submitted as Revision 9, and security procedures that are used to comply with the Plan as it may be further revised in accordance with the provisions of 10 CFR 70.32(e).

Enclosed is the Safeguards Evaluation Report that includes the Categorical Exclusion determination.
