



Item 7. Individual(s) Responsible for Radiation Safety Program and Their Training Experience:

Bryn Mawr College proposes to name Donald L. Abramowitz as the Radiation Safety Officer (RSO) for the Materials License specified above.

He is to replace David Prescott, who is currently named as the RSO in Condition #12 of our Materials License, due to Dr. Prescott's retirement. In addition to the change in RSO, David Prescott should also be removed from the list of Authorized Users found in Condition #11 of the current Materials License at this time.

Donald Abramowitz currently serves as Bryn Mawr College's Environmental Health & Safety Officer, managing the College's overall safety, industrial hygiene, and environmental compliance programs. Mr. Abramowitz has a bachelor's degree in Biology from La Salle University and a master's degree in Environmental Health and Safety from the Harvard School of Public Health. He is a Certified Industrial Hygienist with 26 years of experience in occupational health and safety, roughly half of which have been spent at Bryn Mawr College.

Mr. Abramowitz completed a 40-hour class entitled "Radiation Safety Officer Training for Laboratory Professionals" at the continuing education center at the Harvard School of Public Health on June 12, 2006. (A copy of the certificate of completion is enclosed.) He has also completed a course in ionizing radiation protection while obtaining his master's degree in 1982.

Mr. Abramowitz has presented numerous training classes to the College's faculty, students and staff in various aspects of laboratory safety since 1994, including a radiation safety class in October of 2006.
