SUBJECT: LICENSE AMENDMENT

Please find enclosed Amendment No. 38 to License No. 49-08631-01, **adding the sealed source as requested by letter dated June 1, 2007**. You should review this license carefully and be sure that you understand all conditions. If you have any questions, please contact me at 817-276-6552.

**Please note that a new License Condition was added to this license that requires you to comply with the "Increased Controls for Licensees that Possess Sources Containing Radioactive Material Quantities of Concern" (IC) (ADAMS Accession No. ML053130364) published as "Attachment B" to the "Orders Imposing Increased Controls" (ML053130218) in the Federal Register on December 1, 2005 (70 FR 72128). This License Condition requires you to complete implementation of said requirements by the first day that radionuclides in quantities of concern are possessed at or above the limits specified in "Table 1: Radionuclides of Concern" found in the IC, and notify, in writing, the Director, Office of Federal and State Materials and Environmental Management Programs, U.S. NRC, Washington, DC, 20555, when you have completed the requirements of this License Condition. Our records indicate that you provided a response to the NRC dated December 15, 2005, and that you are currently implementing these Increased Control measures.**

NRC's Regulatory Issue Summary (RIS) 2005-31, provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS. Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

The NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
