SUMMARY

In the telephone conversations on this date with Mr. Snyder, President and RSO, I related our receipt of their letter dated February 16, 2007, which serves as a timely receipt of a renewal application for the subject license. Also, I noted that licenses are normally renewed for a period of ten years rather than five years. Also, I related that current licensing guidance for portable gauges is addressed in NUREG-1556 Vol. 1, Rev. 1, published November 2001 (with ERRATA totally replacing Appendix H) and requested that the licensee resubmit their license renewal application using the guidance in Appendix A (Items 1 through 4) and Appendix B (using the checklist where applicable) of that guidance document. Also, I related that in accord with current NRC policy related to security issues, please provide a total possession limit, to be added to License Item 8 for each radioisotope (Cesium-137, and Americium-241) to be authorized in the subject license, as renewed. I related that the possession limit did not have to be limited to their current total possession but could allow for temporary replacement gauges and/or for planned expansion in gauge usage. To aid in this request, I noted that the Sealed Source and Device Registry authorizes a maximum of 9 millicuries of Cs-137 and 44 millicuries of Am-241 for each gauge that the licensee is authorized to possess. This possession limit information may be inserted in Items 5 and 6 of Appendix B as referenced above.
