SUMMARY

We have reviewed your application dated February 28, 2007, your facsimile dated March 16, 2007, and your letter dated April 24, 2007, requesting a new byproduct materials license and find that we need additional information as follows:

1. Item 5.B. of your letter dated April 24, 2007, requests only non-volatile forms of iodine-131. However, other sections of this letter make reference to the potential use of volatile materials, which will not be authorized under this license. **Please respond by stating that you are withdrawing all references to the potential use of volatile materials in the April 24, 2007, letter.**
2. Under the section of your letter dated April 24, 2007, marked "General Rules for the Safe Use of Radioactive Materials," item 2 states that "eating, drinking.....are not permitted in the manufacturing facility where radioactive materials are used or stored." **Please clarify this statement by removing the language "in the manufacturing facility" so that it is clear that these activities are not permitted anywhere that radioactive materials are used or stored.**
3. The section of your letter dated April 24, 2007, describing your training program for individuals working in or frequenting restricted areas failed to address the assessment of training, the names and qualifications of instructors and the method and frequency of training. **Please revise this section to include the assessment of training, the names and qualifications of instructors and the method and frequency of training.**
4. In order to name you and Brett Dines to this license as authorized users and you as RSO, I'll need to verify your previous employment at Cardinal Health. Your letter dated April 24, 2007, states that Rosalyn Jamison will verbally verify your employment there but you have not provided me with a phone number to reach her at. **Please provide Ms. Jamison's phone number and I will attempt to contact her and obtain written verification of your previous employment.**

Also, for future reference, when submitting the training and experience information for proposed authorized personnel, please do not submit resumes, CV's, or personal, proprietary information that we must protect, in accordance with 10 CFR 2.390, such as social security numbers, dates of birth, home addresses or phone numbers, patient records, college transcripts, etc.

5. Please submit a letter, currently dated and signed by you, as proposed RSO, stating that you accept the position as RSO for this license and that you understand the duties and responsibilities associated with this position.
6. Your website states that you manufacture radiopharmaceuticals and distribute them. This license application does not request such authority, it is for research and development activities only. Please explain and clarify your intentions for this license.
7. I will be conducting a pre-licensing site visit of you and your facilities, etc. in the next few weeks. Please describe your general availability from approximately June 25, 2007 through July 13, 2007.

Please also be reminded of the provisions in 10 CFR 30.9(a), "Completeness and accuracy of information,"...(a) Information provided to the Commission by an applicant for a license or by a licensee or information required by statute or by the Commission's regulations, orders, or license conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

As we cannot issue a new license at this time we are voiding this request in order to enable you to prepare a quality response without time constraints. This is done without prejudice to the resubmission of your request at a later date. Upon receipt of your response we will resume our review. 
