

The purpose of this modification is to provide incremental funding in the amount of \$60,000. Accordingly, the following change is made:

Section B.2 Consideration and Obligation, paragraph (c), the obligated amount is increased by \$60,000 from \$53,000 to \$113,000. Therefore, subparagraph (c) is revised to read as follows:

“(c) The amount currently obligated by the Government with respect to this contract is \$113,000, of which the sum of \$104,630 represents the estimated reimbursable costs, and of which \$ 8,370 represents the fixed fee.”

A summary of obligations for this order, from the date of award through the date of this action, is given below:

This Modification No. 1 obligates FY2007 funds in the amount of \$60,000.
