The purpose of this modification is to: 1) exercise Option Year Two, for a period of performance from September 30, 2007 through September 29, 2008, in accordance with Federal Acquisition Regulation clause 52.217-9, Option to Extend the Term of the Contract, 2) increase the total amount of the contract (ceiling) by \$176,825.50 for Option Year Two, increasing the total ceiling by \$176,825.50, from \$448,993.70 to \$625,819.20, and 3) change the NRC Project Officer from Jeffrey Bartlett to Peggy Sanders, OIS/IRSD, Mail Stop T-5-F-27, phone 301-415-5304, email PKS1@nrc.gov.
