


The purpose of this modification is to (1) add NRCAR 2017.204 "Contracts" (2) extend the period of performance through September 30, 2007 at a no ceiling increase, (3) provide incremental funding in the amount of \$14,000.00 thereby increasing the total obligations from \$552,392.00 to \$566,392.00. Accordingly, the contract is modified as follows:

1) Add the following NRC Acquisition Regulation:

"§2017.204 Contracts

(a) The contracting officer may approve non-competitive extensions, within the limits of his/her delegation, to five-year contracts up to a total of an additional 6 months for the purpose of completing the competitive process for a follow-on contract if the request for procurement action for a follow-on or replacement contract was received in the Division of Contracts and Property Management not less than 6 months before the end of the fifth year.

(b) Other extensions beyond five years must be approved by the Competition Advocate."

2) Period of performance (August 23, 2007 – September 30, 2007)

4) Subsection B.5, DURATION OF CONTRACT PERIOD, delete paragraph in its entirety and substitute with the following in lieu thereof:

"This contract shall commence on August 23, 2002 and will expire on September 30, 2007."
