The purpose of this modification is to exercise Option Year Two (October 1, 2007 through September 30, 2008) of the contract in accordance with Federal Acquisition Regulation (FAR) Clause 52.217-9, Option to Extend the Term of the Contract, thereby extending the term of the contract through September 30, 2008. A preliminary written notice of the Government's intent to exercise this option was issued by letter on May 31, 2007.

Accordingly, the following change is hereby made:

Subsection B.4.14, DURATION OF CONTRACT PERIOD, is deleted in its entirety and replaced with the following in lieu thereof:

"B.4.14 DURATION OF CONTRACT PERIOD

Performance under this contract shall commence on October 20, 2004, and will expire on September 30, 2008. The term of this contract may be extended at the option of the Government for one additional one year period."

This is a no cost to the Government contract; no Government funding is provided.

All other terms and conditions under this contract remain unchanged.
