**INFORMATION REQUEST: FACILITIES POSSIBLY AFFECTED BY PROPOSED LTR-
PREVENTION OF LEGACY SITES RULE (STP-06-087)**

The U.S. Nuclear Regulatory Commission (NRC) is proposing to amend its regulations to reduce the likelihood that facilities will become legacy sites. The amended regulation would require NRC and Agreement State licensees to report how their facility design, construction, and operating procedures will detect and minimize the presence of contamination, in the contiguous and offsite environment, including the subsurface.

To accomplish this task, in June 2006, the NRC formed a proposed rule Working Group comprised of NRC personnel and one Agreement State representative from the Organization of Agreement States (OAS). At this time the License Termination Rule (LTR)-Legacy Sites Working Group (WG) is beginning to identify the number and types of facilities that may be affected by the proposed rule. The types of facilities that will need to submit this report are those who possess or use radioactive material, with a half-life greater than 120 days, in an unsealed form, and, "whose processes have liquid volumes with the potential to contaminate the subsurface environment."

In order to complete this task, the WG is requesting the Agreement States to provide the following information on the types of facilities that NRC believes will be affected by the proposed rule that are currently under the Agreement States' jurisdiction:

- All Part 40 equivalent facilities, including uranium mills and solution mining
- All Part 70 equivalent facilities
- The following Byproduct Material facilities:

Academic Broad Scope
Research and Development
Manufacturing and
DistributionPool irradiators
Nuclear laundry
Decontamination services
Waste disposal services
Waste treatment services
Facilities shutdown or under decommissioning

This correspondence is TN Division of Radiological Health's response to NRC's Information Request: Facilities Possibly Affected by Proposed LTR-Prevention of Legacy Sites Rule (STP-06-087), dated September 18, 2006. The Division has identified which of its licensees are potentially affected. Below are the types of facilities and the corresponding number of Tennessee licensees who have the authorization to possess and process liquids containing radioactive material and, as such, could have liquid volumes with the potential to contaminate the subsurface environment.

- Waste Treatment Services--Eleven (11)
- Manufacturing and Distribution--Three (3)
- Research and Development--One (1)

It is important to note that these licensees may or may not currently possess radioactive materials in liquids, but that their license would not preclude that option.

I suppose asking about quantity of radioactive material on hand or "ever possessed" would be pointless. I will suggest that my staff simply provide me with the count of licensees in each category and call it good!

We do not have a feel for a specific volume of concern. We have wrestled with this in our discussions. A small chronic leak over 20 years can end up with a badly contaminated subsurface, and as you mention, an accident at a facility where there is liquid in close proximity to radioactive material also can be a big problem.

We ask that you consider the operations related problems that contribute to creation of "legacy sites" — these are more due to long-term chronic releases and releases that are not cleaned up promptly, than the accident scenario posed above. I hope this helps with your consideration of the number of facilities that could be affected by the proposed rule who are in the state of Washington. Best regards, Kevin O'Sullivan 301-415-8112

Do you have a "feel" for the volume of concern? A gallon of liquid is probably of little concern, and certainly a mill tailings impoundment is definitely "in", but what about a 100 gallon tank? or a 1,000 gallon tank? Is there a cut-off?

Does the "liquid volume" need to be in a process line that actually involves radioactive material? The presence of liquid anywhere in the facility (but presumably in close proximity to the radioactive materials) could be a problem. A fire, explosion, earthquake, or human error could cause separate "sources" (radioactive materials and a liquid driving force) to come together.

For example, there are 41 active NRC licensees in the Academic (Broad Scope) category, of which 32 of those have a licensee for radioactive material with half-life greater than 120 days in an unsealed form. The number for the Research and Development type facilities (all R&D types) is larger — 394 total and 305 with the long-live unsealed material.

To do the Regulatory Analysis for the proposed rule (prevention of legacy sites), we need to estimate the costs and benefits including both NRC and Agreement State licensees.

Yes, through STP-06-087, NRC is requesting from each Agreement State the total number of each of the types of licenses listed in STP-06-087, where the licensee possesses radioactive material with a half-life greater than 120 days, in an unsealed form, and "whose processes have liquid volumes with the potential to contaminate the subsurface environment."

We looked into the NRC Medical Broad Scope Licenses and decided not to include them in the list because the radionuclides in use at those facilities are primarily short-lived and there have not been reported releases or spills at these types of facilities. You are correct that these licensees do possess long-lived nuclides (H-3, C-14, am-241, Ca-45, Co-60, Cd-109). If you believe the Medical Broad Scope is a comparable risk for subsurface contamination as Academic Broad Scope, please let me know by reply e-mail and we will factor that in.
