Mark, I will have to check on the exact date, but about a week before the writing session for Vogtle, I called Charles Hardigree in Augusta, GA. He is the Business Manager for the Local Union ### Plumbers, Steamfitters, and Pipefitters. The purpose of my call was to confirm the estimated wages of skilled craft construction workers. I did not believe the numbers in the ER were high enough. Mr. Hardigree was not in and called me back the next day. We talked for less than ten minutes, and he confirmed my suspicion that the Southern ER had reported too low a wage for skilled craft workers. He gave me the figure in our EIS as a good representative annual wage for the area.

Katie can give you the union number if you need it before I get a chance to check my records.
