At approximately 1800 hrs., a call was received in the Central Alarm station by (b)(7)(C) from a (b)(7)(C) (b)(7)(C) advising him that money has been stolen from her purse in her office. Post #6, (b)(7)(C) was dispatched to (b)(7)(C) office area. Upon arrival (b)(7)(C) stated to (b)(7)(C) that when she opened her draw around 1800 hrs., she noticed that the beige colored knapsack zipper compartments all open and her red purse half way out. According to (b)(7)(C) she always keeps her purse secured in her knapsack, which is also secured, via zipper, in her desk draw. However, (b)(7)(C) stated that her desk draw was unsecured. When she opened her red purse, she discovered all her cash missing. However, all her credit cards, checkbook and her cell phone were intact. (b)(7)(C) stated that the amount of currency missing was as follows: \$150.00 cash and \$50.00 in Euro. Currency, value in American currency is unknown. The following chronological activity on the part of (b)(7)(C) was as follows: in and out of her office, but in the immediate area, most of the morning until 11:30 am. From 11:30 am until 12:30 am, she went jogging. After jogging, she was back in her office making only periodical trips around her immediate office area. And also from 1330-1500, she attended a staff meeting. According to (b)(7)(C) the last time she seen her money was in the morning around 0745 am, when she first arrived at her office. No other items, according to (b)(7)(C) was taken or damaged. At 1930 hrs., (b)(7)(C) was notified and briefed on theft. At 1941 hrs., Fps Operator #25 was notified and briefed on theft. Fps operator #25 advised (b)(7)(C) that the information will be passed on and (b)(7)(C) will be contacted by an FPS patrol officer and will advise her of an ETS. At 2044 hrs., FPS (b)(7)(C) #1190, arrived on site to do a follow up report on theft.
