This is in reference to your letter dated July 19, 2007 requesting to amend Nuclear Regulatory Commission License No. 29-31028-01 and to the telephone discussion between myself and Carla Fabrizi, your office manager, on August 17, 2007. In order to continue our review, we need the following additional information:

In your July 19, 2007, letter, you requested that Clifford Sebastian, M.D. be approved for and listed on your license as an authorized user on your license. You enclosed a copy of his board certification but the regulations also require that a preceptor attestation statement be included. Enclosed is a copy of NRC Form 313a(AUD). You need to complete the top section of page 1 including checking off the Board Certification statement and all of Part 2 that applies.
