PROCEEDING IN THE MATTER OF PA'INA HAWAII, LLC

In conformance with the Commission's policy on notification of the Atomic Safety and Licensing Board (Board) and all parties of new, relevant, and material information, this memorandum provides the information discussed below.

The U.S. Nuclear Regulatory Commission (NRC) staff (Staff), has performed an environmental assessment of Pa'ina Hawaii, LLC's application for the possession and use of byproduct material in a commercial underwater irradiator to be located near the Honolulu International Airport and reached a Finding of No Significant Impact on human health and the environment for the proposed licensing action. In addition, the Staff has performed a safety evaluation of the license application. Based on these evaluations, the Staff notified Pa'ina Hawaii, LLC that it had been issued a license for possession and use of byproduct material on August 17, 2007 (enclosed).

This information is being brought to the attention of the Board and all parties, as it may be relevant and material to the Pa'ina Hawaii proceeding.
