

Provide for a downward adjustment to the cost ceilings for task orders 5, 8, 14, 17, 19, 20, 21, 22, 25, 27, 28, 29, 34, 38, 42, 46, 47 and an upward adjustment on the cost ceiling for task orders 13, 26, 33, 43 to reflect an increase/decrease in the level of effort in accordance with the revised cost estimate (Attachment No. 2) and the contractor's e-mail dated, June 26, 2007.
2. Provide incremental funding for task orders 2, 10, 13, 20, 25, 33, 38, 43.

Accordingly, the following changes are hereby made:

- (1) The cost ceilings for task orders 5, 8, 13, 14, 17, 19, 20, 21, 22, 25, 26, 27, 28, 29, 33, 34, 38, 42, 43, 46, 47 are hereby increased/(decreased) from the amount specified under Column B to the revised amount under Column D of the "Task Order Ceiling and Obligation Summary." The obligated amount under Column G shall, at no time, exceed the task order cost ceiling amount under Column D. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount under Column G, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to the task order. Any work undertaken by the Contractor in excess of the obligated amount specified under Column E is done so at the Contractor's risk.
- (2) The obligated amount for task orders 2, 10, 13, 20, 25, 33, 38, 43 are hereby increased/(decreased) from the amount specified under Column E to the revised amount under Column G of the "Task Order Ceiling and Obligation Summary." The obligated amount under Column G shall, at no time, exceed the task order cost ceiling amount under Column D. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount under Column G, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to the task order. Any work undertaken by the Contractor in excess of the obligated amount specified under Column G is done so at the Contractor's risk.
