

The purpose of this modification is to exercise option year #2 in accordance with 52.217-9, and increase the contract ceiling by \$225,561.60 from \$578,556.80 to \$804,118.40.

The Delivery Order is hereby modified as follows:

1. **Section 8.0 Period of Performance** of the Statement of Work (SOW) is deleted entirely and replaced with the following:

8.0 Period of Performance

"The period of performance of this order is October 1, 2005 through December 2, 2008 with one (1) one-year option."

2. The first sentence of paragraph (a) under section **9.0 Consideration and Obligation – Task Orders (Aug 1989) Alternate 1 (Jun 1991)** of the SOW is revised to read as follows:

9.0 Consideration and Obligation – Task Orders (Aug 1989) Alternate 1 (Jun 1991)

"(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$804,118.40."

3. Paragraph (a) under section **24.0 52.216-18 Ordering (Oct 1995)** of the SOW is revised to read as follows:

24.0 52.216-18 Ordering (Oct 1995)

"(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from October 1, 2005 through December 2, 2008."
