The licensee reported the loss and recovery of an Amersham 74 GBq (2 Ci) Cs-137 sealed well logging source (model CDC.CY13, serial #2299GW). The licensee shipped the source via Federal Express. The package containing the source was picked up in Houston, Texas, and was to be transported to Anchorage, Alaska. On 12/8/98, the licensee contacted Federal Express to determine the location of the package, as it had not been received. On 12/15/98, Federal Express contacted the licensee and reported that the package could not be found. Federal Express stated that the package was tracked to the Federal Express hub in Indianapolis, Indiana, but that no further tracking information was available. Federal Express determined that the source was not at their Indianapolis hub. The source was recovered in Oakland, California on 2/19/99.
